



Final electricity consumption by sector in Cyprus 2015-2016-2017






Breakdown of the total final electricity consumption in the tertiary sector by District in 2017






Final electricity consumption in MWh by economic activity of tertiary sector in 2017






Number of Establishments of the tertiary sector by District for 2015

Number of Establishments of the tertiary sector by climatic zone for 2016












