### **NOTE FOR THE ATTENTION OF THE MEMBER STATES**

**Subject: AD672 Anti-dumping investigation concerning imports of birch plywood originating in Russia**

Please find attached the limited draft Commission Implementing Regulation imposing provisional anti-dumping measures in the above mentioned case.

This is a consultation of the Member States prior to the imposition of provisional measures under Article 8(5) of Regulation (EU) No 182/2011 of the European Parliament and of the Council laying down the rules and general principles concerning mechanisms for control by Member States of the Commission's exercise of implementing powers.
