ANNEX 1: Summary of the proposed duties for information purposes only for AD673 Anti-dumping investigation concerning imports of aluminium converter foil originating in the People's Republic of China

In accordance with Article 19a of Regulation (EU) 2016/1036 of the European Parliament and the Council of 8 June 2016 on protection against dumped imports from countries not members of the European Union¹ ('the basic Regulation'), as last amended by Regulation (EU) 2018/825 of the European Parliament and of the Council of 30 May 2018², and with regard to the anti-dumping investigation concerning imports of aluminium converter foil originating in the People's Republic of China ('PRC'), the Commission provides, with this annex, a summary of the proposed provisional duties for information purposes only.

All exporting producers, for whom individual calculation was done, will receive details of the calculation of their individual provisional anti-dumping duties.

Product scope

- 1. The product subject to the provisional duties is aluminium converter foil of a thickness of less than 0,021 mm, not backed, not further worked than rolled, in rolls of a weight exceeding 10 kg, originating in the PRC, currently classified under CN code ex 7607 11 19 (TARIC codes 7607 11 19 60 and 7607 11 19 91)
- 2. The following products shall be excluded from the products described in point (1) above:
 - (a) Aluminium household foil of a thickness of not less than 0,008 mm and not more than 0,018 mm, not backed, not further worked than rolled, in rolls of a width not exceeding 650 mm and of a weight exceeding 10 kg.
 - (b) Aluminium household foil of a thickness of not less than 0,007 mm and less than 0,008 mm, regardless of the width of the rolls, whether or not annealed.
 - (c) Aluminium household foil of a thickness of not less than 0,008 mm and not more than 0,018 mm and in rolls of a width exceeding 650 mm, whether or not annealed.
 - (d) Aluminium household foil of a thickness of more than 0,018 mm and less than 0,021 mm, regardless of the width of the rolls, whether or not annealed.
