In addition, the system provides controlled shade and protection of crops against extreme weather events and intense and long-lasting solar radiation, while the soil below remains productive.</p> <p>This standard can be used as a reference for the analysis, definition, design, implementation and implementation of hortivoltaic systems, including for documenting good practices, ensuring integrated functionality and optimizing resource use, as well as for the evaluation and monitoring of microclimate parameters, carbon footprint and system integration in the horticultural technological chain, including in the post-harvest stages.</p> <p>The standard is applicable to organizations that design, integrate and install agrivoltaic systems, as well as to farms and other entities operating in the field of horticulture or related fields, interested in integrating sustainable horticultural production with energy production. The certification of a hortivoltaic system, according to this standard, can only be achieved after validating its compliance with the requirements defined for hortivoltaic systems. This standard is applicable only to integrated hortivoltaic systems, regardless of their origin, which are intended for use in pedoclimatic conditions specific to the horticultural sector, in compliance with the requirements and regulations applicable in the implementation area.</p>
